There will be no vehicle zone in the campus; mapping will be done. Construction of solar plant of 1.6 MV is under process and it will be completed by November 2021, which will supply the electricity to the entire campus and also can be outsourced.	Tree plantation drive was initiated and more plantations are done in the campus. No vehicle zone created in the campus. Construction of solar plant of capacity 1.6 MV is completed and it is functional since November 2021. It has reduced the electricity bill of the campus to a large extent.
