This Memorandum of understanding (MOU) is made and executed on 25th September 2018 by and in between

 Nerul, Navi Mumbai and dealing in Operations of Live Medical Counselling and Satellite Based PG-NEET
 counselling sessions for Medical Students.
- 2. Whereas P.D.V.V.P.F's Medical College is a private Medical College situated at Ahmednagar, Maharashtra dealing and offering MBBS, Dental, Nursing and Physiotherapy through their UG, PG and Diploma courses to the aspiring students.
- 3. IATSD is keen and interested in helping and educating the students of P.D.V.V.P.F's Medical College to crack the NEET-PG exam conducted by the Government of India, year on year. IATSD also has modular programs for students from each year of MBBS curriculum and partly for students from BDS and Nursing too.
- 4. IATSD perceives that there are huge benefits that can be accrued to students and Management of P.D.V.V.P.F's Medical College through these IATSD Live counselling and satellite educational programs. A few tangible benefits could be listed as below

- 5. The benefits accrued to the students are
 - a. IATSD charges a very small amount towards the educational program as it is processed through a foundation.
 - b. Comfortable and spacious classrooms, pleasant study environment, study and exam material at nominal cost.
 - c. We also undertake NEET PG counselling sessions for Interns, which improve their understanding about the exam patters, methodology of questions, type of studies required and style of answering in NEET PG exam for getting best results.

Now this Memorandum of Understanding witnesses as under

The following has been discussed and agreed between IATSD and P.D.V.V.P.F's Medical College, Ahmednagar -

- 1. The duration of this MOU would be for a period of **5** (Five) years from the date of its signing and will be honoured and binding on all future office bearers of both the Institutions.
- To start with IATSD team would address all the students of Medical, Dental and Nursing the college, briefing them about HTHPF, IATSD, Live Medical counselling and Satellite counselling system, the activities, the techniques, approach, structure, track record etc and would also bring upon the benefits of joining the differently conceptualized and specially developed training modules which makes it extremely easy to crack the PG-NEET Exam.
- 3. P.D.V.V.P.F's Medical College would grant permission for any follow-up seminars or Skill development programs that IATSD may arrange for its students from time to time through experts from DBMCI or from various Industries.
- 4. P.D.V.V.P.F's Medical College would make available an appropriate auditorium / Lecture hall and an audio video projection system for all such seminars / special sessions.
- 5. P.D.V.V.P.F's Medical College would allot a suitable Lecture hall / auditorium to IATSD for operating their special training lecture program on daily basis. This room would be equipped with classroom furniture adequate for seating around 150 students at a time. IATSD would thereafter install the satellite signal reception, processing and projection equipment to conduct daily classes for P.D.V.V.P.F's Medical College students who will join the specialized training program. The above hall / room would be used by IATSD for the period of the MOU, and P.D.V.V.P.F's Medical College would have the authority to supervise and inspect the premises as per their requirement.
- 6. P.D.V.V.P.F's Medical College would appoint a competent and suitable coordinator.
- 7. P.D.V.V.P.F's Medical College would share the students details namely names, Mobile numbers, emails course and class of study with IATSD, wherein IATSD can send emails and text messages giving information about the course schedules, changes and upcoming events including Exams and special seminars.
- 8. It was further agreed that P.D.V.V.P.F's Medical College would allow IATSD to distribute and display some promotional material at notice boards within P.D.V.V.P.F's Medical College campus.
- 9. P.D.V.V.P.F's Medical College also agrees to help IATSD in promoting its programs amongst the college students and encourage the students to take up its different courses and modules.

- 12. IATSD would ensure the following towards their commitment to P.D.V.V.P.F's Medical College and the students who enrol for IATSD Counselling program
 - a. Procure an independent Satellite receiver & transmitter including its associated direct telecast system/s & rights and install the system at MIMSRIs designated premises.
 - b. Ensure all relevant Doctors are made available for the lectures
 - c. Ensure that the course completes within the stipulated time including the conduct of review and periodic exams.
 - d. IATSD would strive to ensure conducting all classes without problems / breaks.
- 13. IATSD and P.D.V.V.P.F's Medical College agree to conduct periodic meeting with student's coordinators to resolve any issues and to seek improvements in our deliverables.
- 14. It is additionally agreed that P.D.V.V.P.F's Medical College would look after and ensure
 - a. Safety and Security for all the infrastructure and property created & installed by IATSD at P.D.V.V.P.F's Medical College Ahmednagar campus.
 - b. Give entry permissions to members of IATSD, HTHPF, Counselling faculty, Visiting Faculty, Specialist from other fields on as and when required basis.
 - c. Handle all Discipline related issues of Students related to our training sessions.
 - d. Provide Suggestions, Guidance and Feedback at regular intervals to IATSD to improve our services & deliverables.
 - e. Provide and ensure uninterrupted, stable, electrical supply during the period of classes for the entire period of the MOU.
 - f. Provide unrestricted permission to remove the property and infrastructure from P.D.V.V.P.F's Medical College Ahmednagar campus, whenever IATSD desire to do so may be for up-gradation / repair / replacement/ permanent removal.
 - g. Considering that our HTHPF foundation is established with the Aim to serve humanity with a Social cause, we request P.D.V.V.P.F's Medical College Management to support us in our Aim.
 - h. Provide a small, independent, lockable room to function as administrative office of IATSD within the college campus with basic minimum office furniture.
 - i. Permit the hostel students to attend the Counselling sessions till its finish / end time.
- 15. It is agreed by and between P.D.V.V.P.F's Medical College Ahmednagar and IATSD that latter would pay the former 10 % (Ten percent) of the total fees collected from the students towards these Counselling sessions, administrative and overhead charges. This payment would be made through crossed cheque / NEFT within a month after payment of students is received by IATSD. Supervision on admission process will be through student coordinator P.D.V.V.P.F's Medical College.
- 16. In good faith IATSD may to contribute towards annual college festival as feasible.
- 17. It is agreed that IATSD would do all the marketing for the offered counselling sessions with the students, and P.D.V.V.P.F's Medical College would support IATSD in this regards through promotion of the program through their internal circulars, word of mouth and assemblies.
- 18. The following has been agreed regarding the EXIT policy by and between P.D.V.V.P.F's Medical College and IATSD-





- a. Either of the parties involved herein can exit the MoU by informing the other party in writing along with reasons for the Exit and by giving 90 days notice.
- b. Heads / Undersigned of either party would meet along with their representatives, office bearers, and lawyers to discuss and resolve any outstanding issue or dispute.
- c. Only after repeated failure of fruitful talks, the parties would take the extreme step of exiting from the MOU
- 19. The centre being started at P.D.V.V.P.F's Medical College would be a big support even for the medical college students in the radius of 80 kms hence P.D.V.V.P.F's Medical College and IATSD agree to invite such colleges and facilitate such students as well.
